GAMECOURT® PVC Sports Flooring Warranty
Revised 4-14-09

Moose Sports Surfaces, Ltd. (Moose) warrants its **GAMECOURT PVC®** and welding rods to be free from manufacturing defects for 10 years from substantial date of completion. Moose does not warrant installers' workmanship. Workmanship errors should be addressed to the contractor who installed the floor.

Terms of Warranty:

1. The **GAMECOURT PVC®** is correctly installed over a properly prepared sub-floor.
2. The floor is regularly maintained using an approved maintenance system as laid out in the **GAMECOURT PVC®** Care & Maintenance Guide and using properly maintained equipment and the appropriate cleaning tools.
3. **Within One Year:** If a defect covered by this warranty is reported to Moose in writing within one year of purchase, Moose will supply new material of the same or similar grade sufficient to repair or replace the defective material.
4. **Within Two Years:** If a defect covered by this warranty is reported to Moose in writing after one year but within two years of purchase, Moose will supply new material of the same or similar grade sufficient to repair or replace the defective material.
5. **After Two Years:** If a defect covered by this warranty is reported to Moose in writing after two years but within five years of purchase, Moose will supply new material of the same or similar grade sufficient to repair or replace the defective material.

Warranty Exclusions. The warranty does not cover the following:

1. Improper Installation and/or maintenance.
2. Problems arising from excessive moisture, alkali, or water pressure from the sub-floor.
3. Difference in color between products and samples or photographs.
4. Discoloration due to U.V. light, heat sources.
5. Surface scratches, changes in shading, texture, and/or gloss during use.
6. Indentations from improper loading including high heels, spiked shoes, rolling loads, and furniture not using floor protectors.
7. Damage caused by chemically reactive materials, carpet crocking, dye, mold, stains, spillages, burns, gouges, scratches, indentations, floods, accidents, abuse, or any harsh scouring pads while buffing.
8. Moose excludes and will not pay incidental or consequential damages under this warranty. By this we mean any loss, expense, or damage other than on the flooring itself that may result from a defect in the flooring. No implied warranties extend beyond the terms of this written warranty. Note: Some states do not allow exclusion or limitations of incidental or consequential damages or limitations on how long an implied warranty lasts, so the above limitations or exclusions may not apply to you. This warranty gives you specific legal rights, and you may also have other rights which vary from state to state.

There are no warranties beyond this expressed warranty. All other warranties, including warranties of merchantability or fitness for a particular purpose, are excluded. Moose excludes any liability for lost profits or any other indirect, special or consequential damages. The remedies contained herein are the only remedies available for breach of this warranty.
